CHARTER OF THE BIOMETRICS SECTION INTERNATIONAL CHINESE STATISTICAL ASSOCIATION

ARTICLE I - NAME

This Section shall be known as the Biometrics Section of the International Chinese Statistical Association (ICSA).

ARTICLE II - PURPOSE

The purpose of the Biometrics Section (hereafter referred to as the Section) is to vigorously pursue the objectives of the ICSA with the special interest in biometrics, to foster in the broadest manner biometrics and its application, and to promote unity and effectiveness of effort among all individuals and groups in the biometrics community who have an interest in, or are concerned with, biometrical problems. The activities of the Section shall be directed toward the exclusive goals of contributing to the further development and application of the biostatistical science and to providing biostatistical supports in the public interest matters.

ARTICLE III - MEMBERSHIP

The membership of the Section shall include all ICSA members who indicate to the Secretary of the ICSA an interest in the activities of the Section.

ARTICLE IV - OFFICERS AND REPRESENTATIVE

1. Officers and Representative.

The officers of the Section shall consist of the Chair, the Chair-Elect (who also serves as the Vice-Chair), the Secretary, and the Treasurer. The Section shall also have a Representative, elected by Section members, on the ICSA's Board of Directors as stated in the ICSA's Constitution.

2. Terms.

The terms of the Chair and Chair-Elect/Vice-Chair shall be one year, and the terms of the Secretary and treasurer shall be two years. The term of Representative to ICSA Board of Directors shall be as prescribed in the ICSA's constitution.

No officers other than the secretary and the treasurer shall be eligible for immediate reelection to the same office.

The Chair-Elect/Vice-Chair shall automatically succeed the Chair at the annual change of officers which shall occur on

January 1.

3. Vacancy in Offica.

If the office of Chair becomes vacant, the Chair-Elect shall become the Chair, the term extending through the following year. Vacancies in other offices shall be filled by appointment by the Chair with approval of the Executive Committee (See Article V) except a vacancy in the office of Representative to the ICSA's Board of Directors shall be filled as prescribed in the ICSA's Constitution.

4. Nomination and Election.

The immediate past Section Chair shall serve as the Chair of Nomination-Election Committee. Three additional members of the Section, appointed by the Executive Committee, shall serve on this committee.

On or before February 1 of each year the Section Nomination-Election Committee shall submit to the Secretary of the ICSA at least two nominations for each position to be filled.

Balloting shall be carried out as part of the ICSA annual mail ballot for electing ICSA and the Section officers. All balloting procedures shall conform to those used in balloting for ICSA officers.

5. Duties of Officers.

a. The Chair shall be the chief executive officer of the Section, responsible for coordinating its activities and representing it in its relations to ICSA or to other organizations. He/she shall preside at all business meetings of the Section and of the Executive Committee. He/she shall make all necessary appointments with the advice of the Executive Committee and serve as an ex-officio member of all committees.

b. The Chair-Elect/Vice-Chair shall assume the duties of the Chair in the event of the absence or inability of the Chair to serve.

- c. The Secretary shall keep the minutes of all business meetings of the Section and the Executive Committee, shall preserve all important records including reports of Committee, shall carry on official correspondence of the Section, shall send all members notices of the annual business meeting and such other communications as the Executive Committee may direct.
- d. The Treasurer shall be responsible for the collection of membership dues and any other moneys due to the Section, for the custody of its funds, and for the prompt payment of all bills.

Whenever requested by the Executive Committee, he/she present his/her books for audit. He/She shall prepare an budget for approval by the Executive Committee and an financial report for presentation to the membership.

ARTICLE V - EXECUTIVE COMMITTEE

1. Membership.

The Executive Committee shall consist of the officers of the Section, the Representative (to ICSA), the immediate past Chair, and the chairs of all standing committees (see Article VI). The Section Chair shall chair the Committee and the term of Committee members shall begin on January 1.

2. Meeting Frequency.

The Executive Committee shall meet at least once a year. Meeting shall be held at the call of the Section Chair or on written petition signed by three members of the Executive Committee.

3. Powers and Duties

- a. The Executive Committee shall pass upon the annual budget as proposed by the Treasurer and shall determine the amount of Section membership dues. It shall also pass upon any proposal for the use of Section funds outside the budget or any revision of the budget.
- b. It shall be empowered to fill any vacancy among the officers which may occur between elections, except as otherwise provided for in this Charter.
- c. It shall authorize the formation of Special Committees as described in Article VI.
- d. It shall pass upon the plans for any project which a Committee or other Section group proposes to undertake in the name of the Section.
- e. No Committee or other Section group shall pass any public resolutions, speak for, or take other public action, or contract for expenditures, in the name of the Section without approval of the Executive Committee.
- f. It shall determine the time and place of the Annual Meeting.
- g. The Executive Committee shall conduct other business as may arise which is not addressed elsewhere in this Charter.

ARTICLE VI - COMMITTEES

1. Advisory Committee.

The Advisory Committee shall consist of six members, two appointed each year by the Chair to serve a three-year term. No person shall serve on both the Advisory Committee and Executive Committee at the same time. Members of the Advisory Committee shall be chosen to represent various institutional affiliations and areas of interest of ICSA members. The primary function of the Committee shall be to advise the Section Chair on those matters which he/she calls to its attention. It shall also be empowered, by simple majority of its members, to intervene in the conduct of Section business on behalf of the general membership by calling for a referendum on any matter of concern. The Nomination-Election Committee shall then be obliged to conduct a general referendum within thirty days.

2. Standing Committees.

- a. Executive Committee. See Article V.
- b. Nomination-Election Committee. See Article IV.4. and Article VI.1
- c. Program Committee. The Program Committee shall comprise such members as the Committee Chair may appoint. It shall be responsible for the planning and conduct of the Section's program of seminars and conferences..
- d. Membership Committee. The Membership Committee shall comprise at least five members.
- 3. Special Committees. See Article V.3.c. Special Committees may be established on a temporary basis in order to carry through one project or on a continuing basis in order to carry out a function. When a Special Committee is established, the Executive Committee shall designate whether the intention is for it to be temporary or continuing.

4. Appointment to Committees.

See Article IV.5.a. The Section Chair with the advice of the Executive Committee, shall appoint the Chair of each Standing (except the Executive and the Nomination-Election Committees, see Articles IV.4 and V.1) and Special Committee and shall be an exofficio member of each. The term of a Committee Chair shall be one year, but may be reappointed.

ARTICLE VII - MEETINGS

There shall be an annual business meeting, during which election of officers may be held. The purpose of the meeting shall be to inform the membership of Section business and report on its financial status.

ARTICLE VIII - ICSA CONSTITUTION

Any and all provisions of the Constitution of ICSA shall be observed where applicable.

ARTICLE IX - AMENDMENTS

Amendments to this Charter may be proposed by the Executive Committee of the Section or by petitions signed by at least 25 members of the Section and submitted to the Executive Committee. The proposed amendment shall then be submitted to the members of the Section for mail vote. If approved by a majority of the member of the Section voting, the amendment is subject to the approval of the ICSA's Board of Directors. If approved by the Board, the amendment shall be effective immediately.
